

Youmna Fine Jewellery works to ensure your privacy is protected when using our services. We therefore have a policy setting out how your personal data will be processed and protected. Any changes we have made to this data policy can be found by visiting our website.

Personal details

We take responsibility for all the personal data – such as your name, address, email address and date of birth – that you provide us with or that we obtain through purchases, when you order catalogues, subscribe to our newsletter or when you create a personal account on www.youmnafinejewellery.com.

These details are kept within the Youmna Fine Jewellery mother company – Alcyone Ltd - acting as the party responsible for your personal data under Personal Data (Privacy) Ordinance - Cap. 486, Laws of Hong Kong SAR (the "Ordinance").

Youmna Fine Jewellery respects your concerns about privacy and follows strict procedures to protect customer information and ensure that your personal information is handled in a responsible manner. We do not disclose information you provide to third parties.

Why do we take your details and what are they used for?

We use the information that we collect to fulfill our commitments to you and to provide you with the service that you expect. This includes sending you information and offers for marketing purposes. In registering your interest/making an application you consent to our processing your personal details. We will only store your details subsequently with your consent.

We always try to respond to applications as quickly as possible.

Cookies

A cookie is a small text file sent from a website and stored locally on the visitor's hard drive. In your browser you can select a setting that gives you a message before a website sends a cookie to your computer. You can then choose yourself whether to accept or block the cookie. You can also choose to block all cookies. Since different browsers work in different ways, look in your Help menu to find the setting on your browser.

If you choose to block all cookies you can still visit our website, but you will then have to select your country each time you come back.

One reason why we have chosen to use cookies is to store information concerning the country selection you make the first time you visit www.youmnafinejewellery.com. In this way, you avoid having to select a country each time you visit us. The cookie also lets us know whether you have visited our website before and if so, which pages you have looked at. We never use cookies to store personal information about you. We use them only in order to make your visit easier and to keep track of the number of visitors to our website.
